With the advent of Early Voting, the publishing deadline got very early -- as did the deadline for candidate submissions. Less and less candidates were fully participating.

Our candidate forum was well-attended by residents and covered by local media outlets. The Village of Mount Kisco streamed the forum on Facebook Live and made it available afterwards for viewing-on-demand, in both English and Spanish.

In addition, both candidates submitted information to Vote411.org.

## REGISTERING THE FORMERLY INCARCERATED

Our Voter Registration Chair, Allison Chernow, has provided an update and it's an exciting one!

As you know from reading these newsletters, Allison had applied for and received grant money from the League of Women Voters of the United States to work on voter registration of formerly incarcerated people. She partnered with Rehabilitation Through the Arts (RTA); Charles Moore, a formerly incarcerated RTA alum, was going to join her at parole offices and serve as a "credible messenger" as they offered voter registration.

Allison's plan has changed – and grown!
Long story short, she and RTA will be
partnering with other social justice
groups to hold one big voter registration
event that also has a civics component.
The event may also feature elected
officials who were once incarcerated,
providing more "credible messengers."
The League of Women Voters of the US
grant liaison enthusiastically signed off
on the plan and suggested that Allison
contact people at the League of Women

Voters of New York City, who also received a grant to register the formerly incarcerated.

The hope is that by collaborating with other organizations, the event will be higher profile and allow for more voter registration. Watch this space!

## STUDENT OUTREACH

#### STUDENTS INSIDE ALBANY

Pierce & Jesse attended the first inperson SIA conference since 2019. Here was some feedback from Pierce about his experience:

"It was absolutely wonderful as a networking and learning experience! I loved touring the Court of Appeals, Capitol, attending a State Senate and Assembly session, and more. I shadowed the staff of Senator Pete Harckham due to the fact he was absent for his daughter's wedding in England. I also shadowed the staff and Assemblymember Burdick himself...I learned a lot about advocacy groups, interest groups, lobbyists, how they all interact, and policymaking." We are so happy – and relieved – that SIA 2023 went off without a hitch. The pandemic really hit that program hard over the past few years.

## **OTHER**

#### **LWVNYS CONVENTION**

Last month, LWVNEW President Susan Ferris Rights and Secretary Bruce Rights attended the League of Women Voters of New York State's Convention in Albany, acting as our voting delegates. At the LWVNY convention two new studies were adopted.

1. New Study on the use of Ranked Choice Voting and alternatives to party primaries for state, congressional and local offices.

2. New Study on the process used by the state Board of Elections to approve voting systems with the purpose of seeing if the process can be improved to be more effective in ensuring that approved voting systems meet a balance of the SARAT ("secure, accurate, recountable, accessible and transparent") criteria.

Members of local leagues were invited to join the two state committees to research, collect, and review available material about the pros and cons of these issues, including current usage and practices.

As a committee member, you develop questions to guide local leagues' studies and select materials for them to review order for them to agree or disagree with the position.

If consensus is reached by the local leagues and the Board approves, it becomes a state position and all leagues may advocate for its adoption - including at the state level.

# THE NEW YORK STATE EQUAL RIGHTS AMENDMENT

One of the nice things about joining LWVNEW – or any local League – is that you automatically become a member of the County, State, and National Leagues. LWVNEW focuses *overwhelmingly* on local issues...but for members who wish to get involved on a larger level, those opportunities exist.

As many of you know, the New York State Equal Rights Amendment (NOT the ERA from many years ago) is a proposed amendment to the *New York State*  Constitution that adds explicit protections for people who experience discrimination.

Because the constitutional amendment passed twice in two separate NYS legislatures (2022 & 2023), the public will have the opportunity to vote on the measure in 2024.

LWVNEW members Katherine Daniels and Susan Ferris Rights serve on the League of Women Voter's State Taskforce and are working on this measure to get it passed.

The election, in 2024, will be the final step to having this amendment in place. The League feels that a constitutional amendment such as this needs to be in place to permanently protect our rights in the state constitution. The New York State Equal Rights Amendment would enshrine these rights, ensuring that they are protected no matter who is in office.
