UPCOMING VOTER REGISTRATION DEADLINE FOR JUNE PRIMARY

To be clear, this does NOT affect voting in the February 11 special election! Instead, this looks ahead to

New York State's June Primary. If you wish to change your political party affiliation in time to vote in a possible June Primary, the deadline to do so is February 14.

New York's closed primary system means you need to be registered with a political party to vote in that party's primary.

Changes submitted after February 14 won't go into effect until AFTER the June primary.

SCHOOL BOARD CANDIDATE FORUMS

The Bedford Central School District has already reached out to secure a date for a possible candidate forum. The working date as of now is Thursday, May 1. Once the mid-April candidate filing deadline passes, we will know whether a forum is necessary; one would only be held if there were a contested election. A reminder that we traditionally assist the North Salem Central School District with a candidate forum as well. And last year we partnered, for the first time, with the Somers PTO Council to co-sponsor a forum for the contested election there. The Katonah-Lewisboro School

District prefers to have its Parent

Council handle the candidate forums.
