STUDYING WESTCHESTER COUNTY'S PROPOSED 2020 BUDGET

County Budget Director Larry Soule presented the proposed 2020 County Budget at a LWVW-sponsored public

hearing on November 21. The County

NEWS FROM THE STATE LEAGUE (LWVNYS)

LWV REMINDS STATE LEGISLATURE THAT REDISTRICTING DEADLINE APPROACHES

The State League sent a letter to members of the state legislature, reminding them that the deadline for appointing committee members to NY's first independent redistricting commission was fast approaching. LWVNYS is concerned about timely appointments and adequate funding. The new redistricting process was approved by voters in 2014.

CAMPAIGN FINANCE REFORM

The League has been working with the Fair Elections coalition and good government partners to ensure that the Public Campaign Financing Commission proposes comprehensive reforms that will get dark money out of elections. This month, the League signed onto a letter to the Commissioners asking them to

release their interim recommendations in the first week of December. The League asked that they uphold a minimum standard in their recommendations and ensure a 6-to-1 match, a reduction in contribution limits, and the creation of an independent oversight agency to oversee the program.

EARLY VOTING

The League conducted a statewide survey to find out about New Yorkers' experiences voting early for the first time. In total, the League received 1,791 survey responses from voters residing in 54 counties. There were also dozens of emails and phone calls from voters and members reporting issues about their early voting and Election Day voting experiences.

Thanks to those of you who completed the survey and encouraged others to do so. The State League generated a report from the survey results, available below.

LWVUS JOINS U.S. CENSUS AS OFFICIAL PARTNER

The League of Women Voters is now listed as an official partner organization of the U.S. Census Bureau for the 2020 Census! The League's name will be included on the public list of partners and used in presentations by the Census Director, along with the other 750 national companies/corporations/non-profits. The League will also be included on the list submitted to the Under Secretary of Commerce. It is estimated that the total number of national, state, and local partners will be 300,000 by March.
