FORMERLY INCARCERATED

Our outreach in this space continues! Susan Ferris Rights attended an afternoon of presentations in Bedford featuring organizations dedicated to assisting formerly incarcerated individuals. This event was sponsored by Bedford's Prison Relations Advisory Committee (PRAC).

During the event, Susan connected with Pamela Zimba, who runs Lilac House in lower Westchester. Lilac House is committed to addressing the housing gap for formerly incarcerated women in Westchester County and aims to

increase their access to a second chance in a safe community.

Lilac House operates as part of Susan Burton's nationwide model to support women returning from prison. Susan Burton, recognized as a CNN Hero, is the founder of the non-profit organization A New Way of Life and the SAFE Housing Network. Through these initiatives, Burton has helped establish several homes where women can rebuild their lives after incarceration. Lilac House is a proud member of this model and network.

In continuation of their support, Susan and Lisa Pizzurro plan to visit Lilac House to assist the current residents with voter registration.

LWVUS CONVENTION

Many thanks to Nzingha Milanes for attending the LWVUS National Convention as a virtual delegate! Here is her summary:

"I am excited to share with you my recent experience as a virtual delegate for New York at the 56th Biennial LWVUS National Convention, aptly titled "Turn Up and Turn Out," which took place June 27-30 in Washington, DC. Although I participated virtually, I learned a lot and gave my best to represent our local league. I advocated and supported the motion for our sister Westchester league in Scarsdale to make sure that youth league memberships remain free and the local leagues not supplement that fee. It was not passed, as half of all leagues nationally have a student fee, even if it is only nominal.

Our Westchester County President Kathy Meany also advocated with an impassioned plea in person from the floor to support our ILO's.

The event witnessed the participation of over 1,200 League members, board members, and staff from all 50 states, DC, and the Virgin Islands in both inperson and virtual formats. This was the first time the League held this biennial event in the Nation's capital since 2016. An interesting highlight of the convention was that something unexpected happened. An opportunity came up to run for an open seat on the LWV's US nominating committee. I decided to put my name forward,

believing this could be a great way to further contribute to the US league and the mission of the LWV.

Out of the people in person who ran for the two available spots on the National Nominating Committee, I was the only virtual one and placed third.

While I didn't win a spot on the committee, I found the experience invaluable and was happy to contribute to the democratic process in whatever way I could.

It was an eventful moment, especially given that due to technical errors with the leagues voting system for this seat alone, the voting had to be postponed until the following day rather than immediately after our speeches changing the momentum.

Despite being a virtual attendee, it was gratifying to watch our membership actively advocating for various proposals for the League's mission and vision. It inspired me to keep working hard on our local leagues and reminded me of the influence we can exert when we join together for common causes."

NATURALIZATION COURT

(Recap by Allison Chernow and Kimberly Morella): LWVNEW was represented at the July 12th naturalization ceremony by members Del Bashkow and Allison Chernow. One hundred people were sworn in as new citizens by Timothy C. lodoni, Westchester County Clerk. NYS Supreme Court Judge Amy Puerto presided over this court proceeding and made extended, moving remarks by relaying a story about her Italian immigrant background and about her delight in presiding over this

naturalization ceremony for the first time. She exuded warmth and genuine excitement.

After each citizen applicant's name was called, that person came to the front, received the certificate of citizenship, had a photo taken with the County Clerk and Judge, then walked over to Allison and Del to receive LWV brochures about voting and the rights of new citizens. They then were given small American flags and pocket-sized Constitutions by representatives from the Daughters of the American Revolution. As each person received their "gifts," the four of us were able to congratulate them individually on this momentous day—it was truly a privilege to partake in this special and moving ceremony. Impressive, too, was the fact that after the ceremony the newly Naturalized could head to the County Clerk's office, just a floor above, to apply for an official passport from their new country. Also available for these newest members of our community was the opportunity to register to vote directly with





THE NEW YORK EQUAL RIGHTS AMENDMENT



WHAT

The New York Equal Rights Amendment (NY ERA) is a ballot proposal to amend the New York State Constitution.

WHO & WHEN

New York voters will have the opportunity to vote for or against this ballot proposal in the general election on November 5, 2024.

IMPACT

Adding to existing protections against discrimination based on race and religion, this amendment to the New York State Constitution would explicitly prohibit discrimination based on a person's ethnicity, national origin, age, disability, and sex—including their sexual orientation, gender identity, gender expression, pregnancy and pregnancy outcomes, reproductive healthcare and autonomy.
